OFFICIAL CONTEST RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Elder Scrolls® Online ("ESO") Tamriel Together Guild Contest (the "Contest") is sponsored by Bethesda Softworks LLC (the "Sponsor"). For the purposes of the Contest, the "Contest Group" is composed of the Sponsor, together with its affiliates and related companies, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Contest, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Contest and their respective officers, directors, employees, agents, and other representatives.

1. CONTEST PERIOD

The Contest starts on **Wednesday**, **October 14**, **2020** at 10:00:00 a.m. Eastern Time ("ET") and ends on **Friday**, **November 6**, **2020** at 11:59:59 p.m. ET (the "**Contest Period**").

2. ELIGIBILITY

To enter a participant must be an <u>active</u> member of an ESO guild that was established at least thirty (30) days prior to the beginning of the Contest Period. Entries will be submitted on behalf of the participant's ESO guild. All participants submitting entries must be 18 years of age or older at the time of entry, must possess a valid form of identification and be a legal resident of (i) one of the 50 United States (or the District of Columbia) excluding the territories, military installations and commonwealths (ii) Canada (iii) UK, France, Germany, Austria, Poland, Spain, Belgium, Sweden, Switzerland, Norway, Netherlands, Luxembourg, Russia (iv) Australia, New Zealand or (v) Argentina, Mexico, Peru. All applicable federal, national, state, provincial and local laws and regulations apply. Void where prohibited, restricted or taxed by law. Entry materials (the poster image and video) must include somewhere in the asset at least one piece of information that someone could use to learn more information about the guild (ex. a guild Discord channel URL, a guild leader or officer UserID, a guild website URL, etc.) Please do not include any sensitive personally identifying information in the entry materials such as a personal email address or real name.

3. HOW TO ENTER; REPRESENTATIONS AND WARRANTIES; OWNERSHIP OF SUBMISSIONS

NO PURCHASE NECESSARY. Internet access required. To enter the Contest, entrant must Submit your entry during the Contest Period through the entry form at <u>https://woobox.com/jasg7h</u>. There are two (2) categories of entries in the Contest, posters and videos.

1. Poster Entries – Entrants submitting posters shall upload their poster with their entry in JPG or PNG format. Poster entries must be a unique design created by the entrant's ESO guild. Screenshots are not permitted as part of the design. Designs can be created using computer graphics, hand-drawn, painted,

etc. as long as the final product is unique and the file can be uploaded to the entry submissions page as an image.

2. Video Entries – Entrants submitting videos shall include with their entry a URL link to their video as posted on Youtube.com. Video submissions must be no longer than two minutes and uploaded to YouTube. Any music or sound effects used in the video must be from The Elder Scrolls Online or from a royalty-free library. Videos may not include footage from games other than ESO. ESO game footage is not required. Videos may be comprised entirely of out-of-game footage, entirely of ESO in-game footage, or a combination of both.

All entries should include the name of the ESO guild that the entrant is submitting on behalf of. No other method of entry will be accepted. Your entry may not include copyrighted or trademarked materials, including but not limited to logos, artwork and images, other than that which has been permitted for use by the Sponsor (see Section 5: Sponsor Design Elements). The use of copyrighted or trademarked material not owned by Sponsor or yourself is strictly prohibited. Entrants may only submit one entry per category during the Contest Period. It is recommended, but not required, that ESO guilds only submit one Entry per category. A designated ESO guild may only win in one of the two (2) categories. Entry must be submitted by the entrant him or herself. Use of automated devices is prohibited; automated Entries (including but not limited to Entries submitted using any robot, script, macro or other automated service) are not permitted and may result in disqualification.

By submission of an Entry:

(a) you confirm that you have read, understood and agree to abide by these Official Contest Rules;
